We hope that you and your families are doing well during this challenging time, and we urge all community members to follow the recommendations of local leaders and the [Centers for Disease Control and Prevention](#) (CDC).

The COVID-19 outbreak further emphasizes the importance of partnership and collaboration, and we are especially grateful for the work you do to improve the health of our region. We pledge to continue to serve our community and support our partners across our nine-county area of service.
